

PolySoft Surface Control

DESCRIPTION:

PolySoft Surface Control is a formulated algaecide, designed to control algae, mould, bio-film, slime and stains as a result of organic debris. It is suitable for interior or exterior use. Chemically it is a solution of quaternary salts and other active ingredients in water.

The product is classified as non-hazardous according to the criteria of SWA, and is not classified as a Dangerous Good according to the Australian Dangerous Goods (ADG) Code.

APPLICATION:

For heavily soiled areas, a preliminary cleaning is recommended. Use **PolySoft CONCENTRATED CLEANER** diluted 40:1 with water. This will remove any surface contaminant that might disrupt effective wetting of the substrate. Then apply **PolySoft Surface Control** using a brush, sponge, cloth, mop, mechanical or trigger spray device, or by immersion so as to thoroughly wet the surfaces. For spray application, spray 2025mm from the surface. Do not breathe spray. Rub surface with a brush, broom or sponge. Surfaces must remain wet for at least 10 minutes. Change or wash cloths, sponges or brushes frequently to avoid repositioning of soiling.

Initial application of **PolySoft Surface Control** is best carried out as early as possible in the day in order to reduce water evaporation from the sprayed surface. Application should then be repeated in the late afternoon of the same day. If staining is still evident after 5>7 days repeat the sprayed application, and then again at weekly intervals as necessary until all visual evidence of staining is removed.

LONG TERM PROTECTION FROM ALGAE:

Once the surface has been returned to acceptable quality, it is recommended that advice be sought from a reputable pool chemicals supplier regards use of a long life preventative algaecide ideally dosed into the water supply.

PACKAGING:

Available in 5 Ltr and 20 Ltr packs.

PRECAUTIONS:

- Risk- irritation to skin and eyes.
- Wear suitable gloves and protective eye wear.
- Contain spills if safe to do so. Use adsorbent material and then place same in an appropriate container for disposal. Prevent entry into drains, sewers, and other waterways. Dispose of in accordance with applicable federal, state or local requirements.

FIRST AID:

- Ingestion-rinse mouth thoroughly with water and give water to drink. DO NOT induce vomiting. Seek medical advice. Take a copy of the label and/or MSDS with the victim, to the health professional.
- Eyes-immediately irrigate the eye(s) with copious quantity of water for 15 minutes with the eyelids held open. Remove contact lenses if present. Seek medical advice if blurred vision occurs or irritation persists.
- Skin-wash with soap and water and rinse thoroughly. Remove contaminated clothing and wash before re-use.
